**The Honiara City Council Appropriation Ordinance 2025**

3. The sum specified in the preceding section shall be appropriated for the supply of heads and subheads specified in the schedule and in amounts respectively in relation hereto.

**HONIARA CITY ACT 1999**  
(No. 2 of 1999)

## **HONIARA CITY (2025 FEES, RATES AND CHARGES) ORDINANCE 2024**

In exercise of the powers conferred by sections 21, 23, 34 and 35 of the *Honiara City Act 1999* (No. 2 of 1999), the Honiara City Council makes the following law:

### **1 Citation**

This Ordinance may be cited as the *Honiara City (2025 Fees, Rates and Charges) Ordinance 2024*.

## 2 Commencement

This Ordinance commences on 1 January 2025.

## 3 Schedule 1

The fees, rates and charges specified in column 3 of the table in Schedule 1 are the fees, rates and charges to be imposed by the Honiara City Council in 2025 for the services, facilities and permits specified in column 2 of the table in the same row.

## 4 Schedule 2

(1) The fees specified in column 3 of the table in Schedule 2 are the fees to be charged by the Honiara City Council in 2025 for the business licenses specified in column 2 of the table in the same row.

(2) In Schedule 2:

“(FO)” means foreign owned;

“(LO)” means locally owned.

## 5 Repeal

The *Honiara City Council (Fees, Rates and Charges) Ordinance 2024* (Legal Notice No. 96 of 2023) is repealed.
